March 12, 2026

All Documents

- Removal of CarePilot – IQ (Beta) services which were discontinued.

Product Description

- Updated reference from IQ to IQ – Benchmarking.
- Added a new bullet point at the top of the document clarifying that read-only subscriptions:
 - *PCS products may have read-only version of the subscription which will allow Customer to access its data in the known environment. However, Customer cannot add more information. Any SLA agreed for the standard product shall not apply to the read-only subscription.*
